Priority: Food Access

- · Urban agriculture is connected to food insecurity
- Work into every aspect of plan

Goals:

Urban agriculture will never meet all food needs within the city limits.

We need a resilient regional food system to:

- Make an impact on the lives of individual children, families, and neighborhoods
- Teach kids about growing food/transform relationship to food

Farm Incubator Program:

Part of the DOP's ARPA proposal \$11 million in funding; \$1 million -> farm alliance for FIP

Provides funds to farmers of color in urban agriculture

- Stipend for training time
- 15-year lease-to-purchase
- Other forms of land tenure for farmers (leases, sales, land trusts)

Money from state:

Goes to water and power infrastructure.

State isn't interested in land acquisition
