TEMPORARY FOOD SEVICE FACILITY LICENSE APPLICATION EVENTS COVERING 14 DAYS OR LESS (COMAR 10.15.03.02§B)

INSTRUCTIONS

If you are intending to prepare and sell or give away food at a public event such as a fundraiser, carnival, bazaar, meeting or special event you will need to apply for a Temporary Food Service Facility License unless:

- You are a caterer and hold a valid Maryland caterer's license and you intend to complete the major food preparation for the event at your licensed food service facility, or
- You are hosting the event and you or your organization will not directly prepare, sell or give away any food (please complete BCHD Form SPC-EVT).

All others, including restaurants without a caterer's license, must apply for a Temporary Food Service Facility License to participate in the event.

All vendors participating in the event must display either a copy of a valid Maryland caterer's license or a temporary food service facility license at their booth or stand.

To apply, please complete the attached application at least 15 days prior to the scheduled activity.
